Artisan Vendors:

The artisan (vendor) must be the manufacturer and producer of the products intended for sale.

Market season is approximately mid-late March through the 3rd week in December. Thursdays are through the week prior to Thanksgiving. Exact dates to be announced. Single stall fees are \$35/\$45 on Saturdays and \$20/\$30 on Thursdays depending upon stall assignment and location within the market. **Effective 2018 there is a seasonal stall increase of \$5 per stall per day May-July (Fees May-July are \$40/\$50 on Saturdays and \$25/\$35 on Thursdays).**

If offered membership, a **\$100 membership** and the above documents and a signed membership agreement in which **you accept and agree to abide by the rules and regulations of the Modesto Certified Farmers Market** must be received or postmarked no later than **March 6, 2018** to avoid a **\$100 late fee** being assessed. You will be given a copy of the Market's rules and regulations upon acceptance.

Note: Selling at the market is a Thursday/Saturday commitment for the market year. If accepted as a member, you agree to participate as a seller in BOTH markets.

Acceptance as a member **is not a guarantee of a selling space being available for all market days**. Available space is subject to a variety of factors and conditions as determined by the Market Manager on a per market basis. Allowances are made for the Thursday/Saturday commitment mentioned above if selling space in the market is not available on a particular market day.

By signing this application, you agree that you have read the application, filled it out to the best of your ability, agree to abide by the conditions set forth herein and wish to be considered for membership in the Modesto Certified Farmers Market for the 2018 market year.
