- Copy of City of Modesto Business License, if applicable
- Copy of California State Board of Equalization Resale Permit, if applicable
- Copy of Modesto Fire Department permit (if you plan to use a personal heater in your booth)

CERTIFIED FARMERS:

- 2019 Certified Producers Certificate (CPC)
- Farmers 2019 2nd Certificate and Authorization Letter, if applicable
- State Food Processors Registration, if applicable
- Organic Certification/Registration, if applicable
- Nursery License, if applicable

FOOD VENDORS:

- The \$35 health fee must be submitted upon acceptance
- Copy of Stanislaus County Environmental Health Permit (TFF) and/or Food Processors Registration
- Copy of Cottage Food Operation annual registration permit, if applicable
- Copy of Vehicle Vending Permit from Stanislaus County Environmental Health, if applicable
- Copy of City of Modesto Fire Department Permit, if applicable

If offered membership, a \$100 membership, the above documents & a signed membership agreement (in which you accept and agree to abide by the rules and regulations of the Modesto Certified Farmers Market) must be received or postmarked no later than 2 one weeks after you have been officially accepted to avoid a \$100 late fee being assessed. You will be emailed or mailed a copy of the Market's rules and regulations upon acceptance. *By signing this application you acknowledge that you will likely not be accepted immediately to the market, and that although we require at least 3 weeks to process your application, this does not guarantee you will begin in that time frame.* Acceptance will only be considered once a space in your sales category opens up.

For the first time, the Thursday and Saturday markets stand alone and you have the choice to apply for only one or both market days. However, application for one or both market days does not guarantee acceptance. Acceptance will be determined by Jay Tachella (the market manager) and the 2019 Board based on space, need, variety, and past market behavior (if any). Upon acceptance, you are agreeing to commit fully to the days for which you are accepted for.

**By signing this application, you agree that you have read the application in its entirety, filled it out to the best of your ability, agree to abide by the conditions set forth herein and wish to be considered for membership in the Modesto Certified Farmers' Market for the 2019 market year.**
